The state needs to stop bailing out the oil and gas industry. •Coloradans need to focus on protecting their health and families, they should not be distracted by having to respond to new oil and gas drilling proposals in or near their communities. •With the oil and gas industry in economic collapse, Colorado can't afford to keep approving more oil and gas extraction. The state needs to focus on securing financial assurances from companies to ensure full clean up of their operations. •Focus needs to be on adopting stronger safeguards for Colorado's health, environment, and safety. •The Intergovernmental Panel on Climate Change tells us that for a 66% chance of avoiding climate catastrophe by limiting the global average temperature rise no more than 1.5° C above pre-industrial levels, the world must achieve net zero GHG (greenhouse gas) emissions by 2038. •Last year, the Colorado General Assembly passed SB19-096 and HB19-1261, which together establish GHG emissions reduction goals for 2025, 2030, and 2050.
