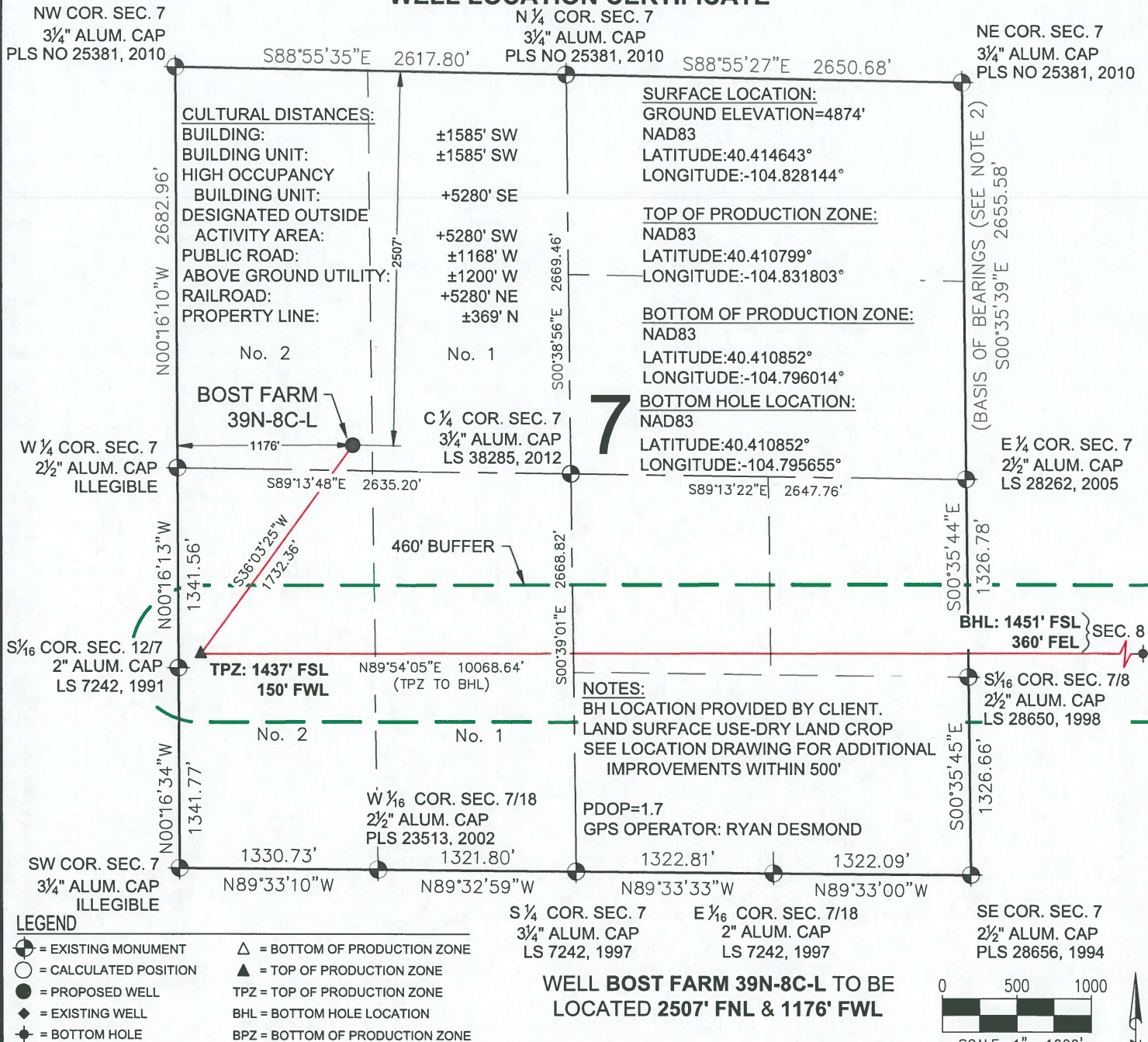


BOST FARM 39N-8C-L WELL LOCATION CERTIFICATE

 - ALL DISTANCES AND BEARINGS SHOWN HEREON ARE GROUND VALUES AS GPS MEASURED IN THE FIELD, WITH TIES TO WELLS MEASURED PERPENDICULAR TO SECTION LINES. THIS LOW DISTORTION PROJECTION (LDP) IS BASED ON THE NORTH AMERICAN DATUM OF 1983, U.S. SURVEY FOOT WITH A LATITUDE ORIGIN OF 40.392315°, A CENTRAL MERIDIAN LONGITUDE OF -104.794248°, AND A SCALE FACTOR ON THE CENTRAL MERIDIAN OF 1.000228 (EXACT). 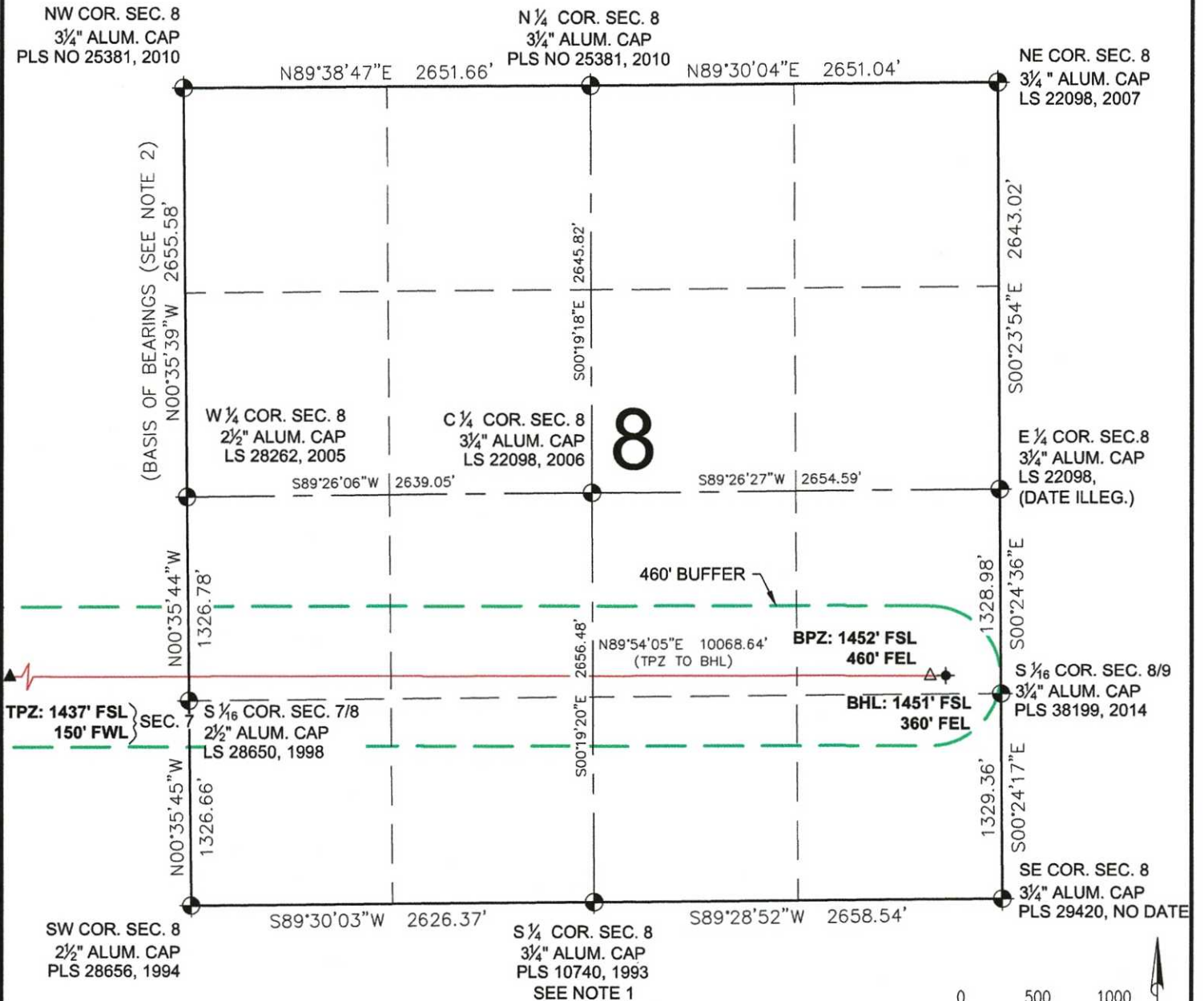

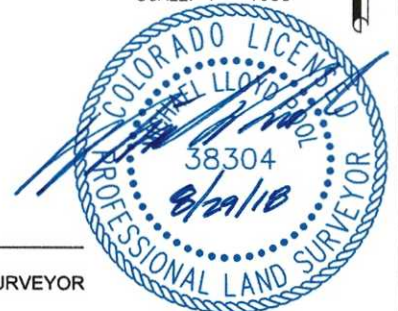
