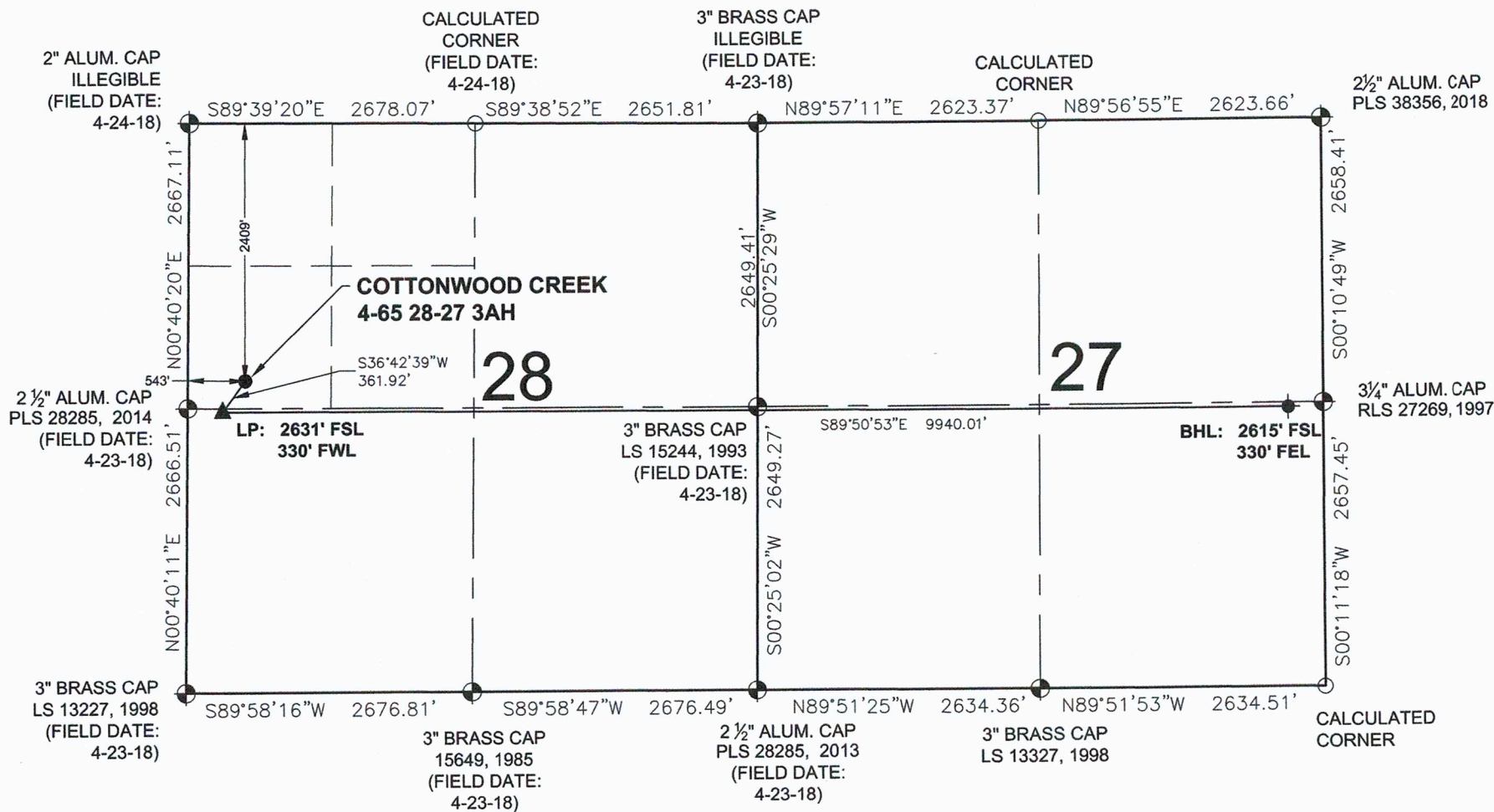


COTTONWOOD CREEK 4-65 28-27 3AH

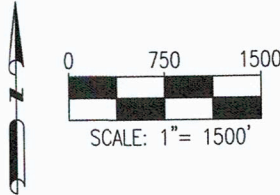
