Remediation of EC in soil less than 3' bgs in the areas surrounding B4, B5, B6, B7 & B8 will be accomplished by surface application of a calcium soil amendment (gypsum). The proposed remediation schedule calls for soil amendment application during the month of November 2017 with attainment of EC & SAR values less than Table 910-1 screening levels in 18 to 24 months verified by soil sample collection and laboratory analysis.

The GP-11 location is currently in interim reclamation status. The soil amendment application caused disturbance to the existing vegetation in the areas of soil borings B4, B5, B6, B7 & B8. The areas were re-seeded with a dryland pasture grass mix by hand broadcasting in the Spring of 2018. Final reclamation will be accomplished after the well is plugged and abandoned. The location will continue to be included in Kinder Morgan's noxious weed prevention program.

OPERATOR COMMENT

Non-E&P waste (pit liner) was observed in four soil borings advanced at the GP-11 site. The drilling pit at the GP-11 location was closed prior to April 1, 2009 and, as documented in the Rule 523.e. Voluntary Self Disclosure Eleventh and Twelfth Quarterly Reports, the GP-11 site does not require a variance to Rule 905. A written agreement with the landowner to leave the pit liner in place is attached to this Form 27.

As stated in the Site Investigation Plan section of this Form 27, soil samples were collected from the same locations and depths (soil borings 4, 5, 6, 7 & 8) of the former drilling pit where EC and SAR concentrations in soil <3' below ground surface exceeded the Table 910-1 screening levels during site characterization soil sampling. The laboratory analytical report (attached) shows the current values (respectively) for EC & SAR to be 1.720 mmhos/cm & 0.67 at soil boring 4, 2.570 mmhos/cm & 0.57 at soil boring 5, 2.680 mmhos/cm & 0.50 at soil boring 6, 0.777 mmhos/cm & 0.33 at soil boring 7, and 0.821 mmhos/cm & 0.28 at soil boring 8. All of the values for EC & SAR in samples collected from shallow soil at the GP-11 site in August 2020 are less than COGCC Table 910-1 screening levels.

Regarding the former drilling pit at the GP-11 production well location, Kinder Morgan submits that the attached landowner agreement and analytical data from the re-sampling of soil borings 4, 5, 6, 7 & 8 provide sufficient documentation to close Remediation Project 9671. Remediation area photo log attached.

	Surface disturbances shall be reclaimed in accordance with the 1000 Series Reclamation Regulations. Consult COGCC Reclamation Specialist regarding interim and/or final reclamation.
	After review of the data presented, elevated levels of [SAR/EC/pH] exist deeper than three feet below ground surface. Per guidance in FAQ 32, elevated levels of [SAR/EC/pH] at three feet below ground surface or deeper should not adversely affect the successful reclamation of the site. If groundwater is found to be impacted, or if reclamation is not compliant with the 1000-series rules, additional remediation activities may be required at the site. It appears that no further action is necessary at this time and COGCC approves the closure request.
