ASSIGNMENT, BILL OF SALE AND CONVEYANCE

This Assignment, Bill of Sale and Conveyance (this “Assignment”), effective as of June 1, 2020 at 12:01 a.m. (the “Effective Time”), is made by and among David M. Baker, solely in his capacity as the court-appointed receiver (“Assignor”) with respect to the assets of Timber Creek Holdings, LLC, Harley Triumph, LLC, Timber Creek Services, LLC, Timber Creek Operating, LLC, and Timber Creek Energy LLC (collectively, the “Timber Creek Entities”), with an address of c/o Aurora Management Partners Inc., 112 South Tryon St. Ste 1770, Charlotte, North Carolina 28284, and Raton Basin Partners, LLC, a Texas limited liability company (“Assignee”), with an address of 112 Bayberry Parkway, Midland, Texas 79705. Assignor and Assignee are each referred to individually as a “Party” and collectively as the “Parties”.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

Assignor hereby **GRANTS, BARGAINS, SELLS, ASSIGNS, CONVEYS, TRANSFERS, SETS OVER, AND DELIVERS** to Assignee all of Assignor’s right, title and interest in and to the following described assets (such interests and properties, but specifically excluding the Reserved Assets, are collectively referred to herein as the “Properties”):

(1) the oil, gas and mineral leases, oil and gas leases, subleases, carried interests, operating rights, minerals and royalty interests, record title interests and other leaseholds and agreements described on **Exhibit A** whether such right, title and interest are legal or equitable, record or beneficial, vested or contingent, together with any and all other right, title and interest of Assignor and Timber Creek Entities in and to the leasehold estate created thereby (collectively the “Leases”), including royalty interests, overriding royalty interests, production payments and other payments out of or measured by the value of oil and gas production from or attributable to the Leases;

(2) all oil and gas wells, salt water disposal wells, injection wells, and other wells and wellbores located on or used in connection with the Leases, whether producing, plugged or unplugged, shut-in or permanently or temporarily abandoned, including those described on **Exhibit B** (collectively the “Wells”);

(3) the surface fee land owned by Assignor and Timber Creek Entities on which is located Assignor’s field office, with any and all fixtures and improvements located thereon and described in detail on **Exhibit C**, (the “Owned Real Property”);

(4) all natural gas, casinghead gas, drip gasoline, natural gas liquids, condensate, products, crude oil and other hydrocarbons (including produced water and carbon dioxide), whether gaseous or liquid, produced from or attributable to the Leases and/or Wells (the “**Hydrocarbons**”) on and after the Effective Time or which are in storage;

(5) all Accounts Receivable related to the Properties;

(6) to the extent transferable, the permits, licenses, servitudes, easements, rights-of-way and other surface use agreements used solely in connection with the ownership and operation of the Properties, including those set forth on **Exhibit D**, (collectively, the “**Surface Rights**”);

(7) all equipment, machinery, vehicles, personal property, fixtures, improvements and facilities appurtenant to and used primarily in connection with the ownership or operation of the Properties or the production, treatment, storage, disposal, or transportation of Hydrocarbons or other substances thereon or therefrom (including all wellhead equipment, pumps, pumping units, Hydrocarbon measurement facilities, flowlines, gathering systems, piping, pipelines, compressors, tanks, treatment facilities, injection facilities, disposal facilities, compression facilities, and other materials, supplies, facilities and machinery) (collectively, the “**Equipment**”), whether located on the Leases, Owned Real Property or held for Assignor or the Timber Creek Entities by a third party;

(8) to the extent transferable, all contracts, agreements, and instruments by which any of the Leases, Wells, Hydrocarbons, Equipment, or Owned Real Property are bound or which otherwise relate thereto, but only such portions thereof to the extent applicable to the Leases, Wells, Hydrocarbons, Equipment or Owned Real Property, including product purchase and sale contracts, gas gathering contracts, salt water disposal agreements, processing or treating agreements, transportation agreements, facilities sharing agreements, compression agreements, production handling agreements, equipment leases, pipeline lease agreements, farmouts and farmins, exchange agreements, purchase and sale agreements and other contracts in which Assignor or the Timber Creek Entities acquired interests in any other Properties, options, orders, unitization, pooling, spacing or consolidation agreements and operating agreements (collectively the “**Contracts**”), including those set forth on **Exhibit E** provided, however, that the term “Contracts” shall not include the Leases and other instruments constituting Assignor’s chain of title to the applicable Leases;

(9) all “**Documents**” and all geophysical data relating to the Properties whether owned or licensed by Assignor, including Assignor’s interpretation of such data, all records and files in the possession of Assignor or the Timber Creek Entities relating to the Properties (collectively, the “**Records**”), save and except for: (A) data, software, and records that Assignor is prohibited from disclosing or transferring under any third party agreement or subjected to payment of a fee or other consideration by any license agreement or other agreement, or by applicable Law, and for which no consent to transfer has been received and/or for which Assignee has not agreed in writing to pay the fee or other consideration, as applicable, (B) information entitled to legal privilege, including attorney work product and attorney-client communications (except for title opinions, which shall be included in the Records), (C) all corporate, financial, Tax, and legal data and records of Assignor that relate to Assignor’s

business generally (whether or not relating to the Properties) or to Assignor's business, operations, assets, and properties not expressly included in the Agreement, and (D) any data and records relating to the Reserved Assets or assets and properties not expressly included in the Agreement;

(10) all of the Timber Creek Entities' interests in all telephone and telephone facsimile numbers and other directory listings used in connection with the Business, to the extent assignable;

(11) all refunds, rebates, credits and similar items of the Timber Creek Entities to the extent related or pertaining directly to any Assigned Contract, existing or arising prior to or on the Closing Date;

(12) rights to proceeds of any rights, claims or causes of action of Assignor arising under or related to intercompany receivables it being understood and agreed that Assignor shall continue to pursue such claims following Closing for the benefit of Assignee;

(13) all rights with respect to overproduction, underproduction, overdelivery or underdelivery of Hydrocarbons produced from or allocated to the Properties or otherwise attributable to any Equipment or Contract, regardless of when such rights arose or whether attributable to any facility, wellhead, pipeline, plant, gathering system, transportation system or otherwise; and

(14) except as excluded as Reserved Assets, below, all other or additional privileges, rights and interests associated with the Properties of every kind and description and wherever located that are used or intended for use in connection with, or that are necessary or helpful to the continued operation of, the Business as presently being operated.

The Properties shall not include, and Assignor hereby reserves and retains, the following (the "**Reserved Assets**"):

(a) all minute books, stock ledgers, corporate seals and stock certificates (or other certificated or uncertificated equity interests) of the Timber Creek Entities and their respective Affiliates;

(b) with respect to any Contract or Surface Rights that relates in part to the Properties and in part to other assets or interests of Assignor that can be assigned in part to Assignee, (i) all portions of such Contract or Surface Rights that do not relate solely to the Properties and (ii) with respect to any Contract or Surface Rights that relates in part to the Properties and in part to other assets or interests of Assignor that cannot be assigned in part to Assignee, the entirety of such Contract or Surface Rights;

(c) all rights and interests of the Assignor or any of its Affiliates (i) under any policy or agreement of insurance or indemnity (including any rights, claims or causes of action of the Assignor and its Affiliates against third parties under any indemnities or hold harmless agreements and any indemnities received in connection with the Assignor's or any of its Affiliates' prior acquisition of any of the Properties) to the extent and only to the extent such rights and interests relate to the ownership of the Properties prior to the Effective Time;

(d) all records of Assignor or any of the Timber Creek Entities that are required by law to remain in their possession, provided that copies thereof in Assignor's possession are provided to Assignee at Closing, to the extent not previously provided to Assignee;

(e) all Hydrocarbons produced from the Properties with respect to all periods prior to the Effective Time and all proceeds from the disposition thereof; and

(f) any Lease, Contract, leased equipment and other leased personal property that is not freely transferrable without payment of a fee or other consideration, unless Assignee has agreed in writing to pay such fee or consideration.

TO HAVE AND TO HOLD the Properties, together with all rights, titles, interests, estates, remedies, powers, privileges, and appurtenances in any way appertaining or belonging thereto, unto Assignee, and its successors and assigns, forever, subject to the terms of this Assignment and the following:

1. *Special Warranty.* Assignor hereby binds itself, its successors and assigns subject, to the limitations set forth herein, to warrant and defend all and singular Defensible Title to the Properties against all claims arising by, through or under Assignor, but not otherwise.

2. *Assumed Obligations.* Assignee hereby assumes and agrees to fulfill, perform, be bound by, pay and discharge (or cause to be fulfilled, performed, paid or discharged) all Assumed Obligations.

3. *Subrogation of Warranties.* Assignor hereby assigns to Assignee all rights, claims and causes of action under title or other warranties given or made by Assignor's predecessors in interest with respect to the Properties, and Assignee is specifically subrogated to all rights which Assignor may have against such predecessors in interest with respect to the Properties, to the extent Assignor may legally assign such rights and grant such subrogation.

4. *Limitation on Representations and Warranties.* EXCEPT FOR THE EXPRESS AND SPECIFIC REPRESENTATIONS AND WARRANTIES OF THE ASSIGNOR IN THIS ASSIGNMENT, THE AGREEMENT, OR THE DEED, THE ASSIGNEE ACKNOWLEDGES THAT (A) THE ASSIGNOR HAS NOT MADE AND THE ASSIGNOR HEREBY EXPRESSLY DISCLAIMS AND NEGATES, AND THE ASSIGNEE HEREBY EXPRESSLY WAIVES, ANY REPRESENTATION OR WARRANTY, EXPRESS, IMPLIED, AT COMMON LAW, BY STATUTE OR OTHERWISE, AND (B) THE ASSIGNOR EXPRESSLY DISCLAIMS, AND THE ASSIGNEE HEREBY EXPRESSLY WAIVES, ANY AND ALL LIABILITY AND RESPONSIBILITY OF THE ASSIGNOR FOR ANY REPRESENTATION, WARRANTY, STATEMENT OR INFORMATION MADE OR COMMUNICATED (ORALLY OR IN WRITING) TO THE ASSIGNEE OR ANY OF ITS AFFILIATES, EMPLOYEES, AGENTS, CONSULTANTS OR REPRESENTATIVES (INCLUDING ANY OPINION, INFORMATION, PROJECTION OR ADVICE THAT MAY HAVE BEEN PROVIDED TO ANY SUCH PERSON).

EXCEPT FOR THE EXPRESS REPRESENTATIONS AND WARRANTIES OF THE ASSIGNOR IN THIS ASSIGNMENT, THE AGREEMENT, OR THE DEED, AND WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, THE ASSIGNOR EXPRESSLY DISCLAIMS AND NEGATES, AND THE ASSIGNEE HEREBY WAIVES, ANY REPRESENTATION OR WARRANTY, EXPRESS, IMPLIED, AT COMMON LAW, BY STATUTE OR OTHERWISE, AS TO ANY OF THE FOLLOWING: (A) THE ACCURACY, COMPLETENESS OR MATERIALITY OF RECORDS, INFORMATION, DATA OR OTHER MATERIALS (WRITTEN OR ORAL) NOW, HERETOFORE OR HEREAFTER FURNISHED TO THE ASSIGNEE BY OR ON BEHALF OF THE ASSIGNOR; (B) THE CONTENTS, CHARACTER OR NATURE OF ANY REPORT OF ANY PETROLEUM ENGINEERING CONSULTANT, OR ANY ENGINEERING, GEOLOGICAL OR SEISMIC DATA OR INTERPRETATION, RELATING TO THE PROPERTIES; (C) ANY ESTIMATES OF THE VALUE OF, OR FUTURE REVENUES GENERATED BY, THE PROPERTIES; (D) PRODUCTION RATES, RECOMPLETION OPPORTUNITIES, DECLINE RATES, GAS BALANCING INFORMATION, OR THE QUALITY, QUANTITY, VOLUME, OR RECOVERABILITY OF THE RESERVES OF HYDROCARBONS, IF ANY, ATTRIBUTABLE TO THE PROPERTIES OR THE ASSIGNOR'S INTEREST THEREIN; (E) TITLE TO ANY OF THE PROPERTIES; (F) MAINTENANCE, REPAIR, CONDITION, QUALITY, SUITABILITY, MARKETABILITY, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE OF THE PROPERTIES; (G) ANY RIGHTS OF PURCHASERS UNDER APPROPRIATE STATUTES TO CLAIM DIMINUTION OF CONSIDERATION OR RETURN OF THE PURCHASE PRICE; (H) ANY IMPLIED OR EXPRESS WARRANTY OF FREEDOM FROM DEFECTS, WHETHER KNOWN OR UNKNOWN, (I) ANY AND ALL IMPLIED WARRANTIES EXISTING UNDER APPLICABLE LAW; AND (J) THE ENVIRONMENTAL OR OTHER CONDITION OF THE PROPERTIES, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED OR EXPRESS WARRANTY REGARDING ENVIRONMENTAL LAWS, THE RELEASE OF SUBSTANCES, WASTES OR MATERIALS INTO THE ENVIRONMENT, OR PROTECTION OF THE ENVIRONMENT OR HEALTH. IT IS THE EXPRESS INTENTION OF THE ASSIGNEE AND THE ASSIGNOR THAT, EXCEPT FOR THE EXPRESS REPRESENTATIONS AND WARRANTIES OF THE ASSIGNOR IN THIS ASSIGNMENT, THE AGREEMENT, AND THE DEED AND EXCEPT AS OTHERWISE SPECIFICALLY PROVIDED IN SECTION 3.2 OF THE AGREEMENT WITH RESPECT TO ADJUSTMENTS TO THE PURCHASE PRICE, THE PROPERTIES ARE BEING ACCEPTED BY THE ASSIGNEE, "AS IS, WHERE IS, WITH ALL FAULTS AND DEFECTS" AND IN THEIR PRESENT CONDITION AND STATE OF REPAIR, AND THE ASSIGNEE HAS MADE OR WILL MAKE SUCH INSPECTIONS AS THE ASSIGNEE DEEMS APPROPRIATE.

THE ASSIGNEE ACKNOWLEDGES THAT (A) THE PROPERTIES HAVE BEEN USED FOR EXPLORATION, DEVELOPMENT, AND PRODUCTION OF OIL AND GAS AND THAT EQUIPMENT AND SITES INCLUDED IN THE PROPERTIES MAY CONTAIN ASBESTOS, NATURALLY OCCURRING RADIOACTIVE MATERIAL ("NORM") OR OTHER HAZARDOUS SUBSTANCES; (B) NORM MAY AFFIX OR ATTACH ITSELF TO THE INSIDE OF WELLS, MATERIALS, AND EQUIPMENT AS SCALE, OR IN OTHER FORMS; (C) THE WELLS, MATERIALS,

AND EQUIPMENT LOCATED ON THE PROPERTIES OR INCLUDED IN THE PROPERTIES MAY CONTAIN NORM AND OTHER WASTES OR HAZARDOUS SUBSTANCES; (D) NORM CONTAINING MATERIAL AND/OR OTHER WASTES OR HAZARDOUS SUBSTANCES MAY HAVE COME IN CONTACT WITH VARIOUS ENVIRONMENTAL MEDIA, INCLUDING AIR, WATER, SOILS OR SEDIMENT; AND (E) SPECIAL PROCEDURES MAY BE REQUIRED FOR THE ASSESSMENT, REMEDIATION, REMOVAL, TRANSPORTATION, OR DISPOSAL OF ENVIRONMENTAL MEDIA, WASTES, ASBESTOS, NORM AND OTHER HAZARDOUS SUBSTANCES FROM THE PROPERTIES.

THE ASSIGNOR AND THE ASSIGNEE AGREE THAT, TO THE EXTENT REQUIRED BY APPLICABLE LAW TO BE EFFECTIVE, THE DISCLAIMERS OF CERTAIN WARRANTIES CONTAINED IN THIS PARAGRAPH 4 ARE "CONSPICUOUS" DISCLAIMERS FOR THE PURPOSES OF ANY APPLICABLE LAW, RULE OR ORDER.

5. *Subject to the Agreement.* This Assignment is made subject to the terms and conditions of that certain Purchase and Sale Agreement dated June 25, 2020, by and between Assignor and Ogris Operating, LLC (the "Agreement"). Capitalized terms used but not defined herein shall have the respective meanings set forth in the Agreement.

6. *Further Assurances.* Each Party shall execute, acknowledge and deliver to the other such further instruments, and take such other actions as may be reasonably necessary to carry out the provisions of this Assignment.

7. *Governmental Assignments.* Assignor and Assignee shall execute separate governmental form assignments of the Properties, if required by applicable Law, on officially approved forms in sufficient counterparts to satisfy applicable statutory and regulatory requirements. Any such separate assignments (a) shall evidence this Assignment and assignment of the applicable Properties herein made and shall not constitute any additional assignment of the Properties, (b) are not intended to modify, and shall not modify, any of the terms, covenants and conditions or limitations on warranties set forth in this Assignment or the Agreement and are not intended to create, and shall not create, any representations, warranties or additional covenants of or by Assignor or Assignee, and (c) shall be deemed to contain all of the terms and provisions of this Assignment, as fully and to all intents and purposes as though the same were set forth at length in such separate assignments.

8. *Entire Agreement.* This Assignment, the Agreement, and the other documents executed and delivered pursuant to or in connection with the Agreement collectively constitute the entire agreement between Assignor and Assignee with regard to the subject matter hereof, superseding all prior statements, representations, discussions, agreements and understandings.

9. *Governing Law; Jurisdiction; Service of Process; Waiver of Jury Trial.* WITH RESPECT TO MATTERS RELATING TO THE CREATION, TRANSFER, PERFECTION OR NATURE OF AN INTEREST IN REAL PROPERTY, LEASES, RENTS OR OTHER PROPERTY OF ASSIGNOR COVERED BY THIS ASSIGNMENT AND LOCATED IN A JURISDICTION OTHER THAN THE STATE OF TEXAS, AND PROCEDURES RELATING

TO THE RECORDATION OF THE ASSIGNMENT OR OTHER CONVEYANCE INSTRUMENT RELATED TO SUCH PROPERTY, OR THE ENFORCEMENT OF ANY RIGHTS IN AND TO SUCH PROPERTY AS SET FORTH IN THIS ASSIGNMENT OR THE AGREEMENT, THIS ASSIGNMENT SHALL BE GOVERNED BY, AND BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE JURISDICTION IN WHICH SUCH PROPERTY IS LOCATED, IT BEING UNDERSTOOD THAT, EXCEPT AS EXPRESSLY SET FORTH ABOVE IN THIS **PARAGRAPH 9** AND TO THE FULLEST EXTENT PERMITTED BY THE LAW OF THE STATE OF COLORADO, THE LAW OF THE STATE OF TEXAS (WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES) SHALL GOVERN ALL MATTERS RELATING TO THIS ASSIGNMENT AND THE OBLIGATIONS ARISING HEREUNDER OR THEREUNDER. By its execution and delivery of this Assignment, each of the Parties hereto irrevocably and unconditionally agrees for itself that any legal action, suit or proceeding between Assignor, on the one hand, and Assignee, on the other hand, with respect to any matter under or arising out of or in connection with this Assignment or for recognition or enforcement of any judgment rendered in any such action, suit or proceeding, shall be brought in the Court for that purpose only, and, by execution and delivery of this Assignment, each Party hereby irrevocably accepts and submits itself to the jurisdiction of such Court, generally and unconditionally, with respect to any such action, suit or proceeding. In the event any such action, suit or proceeding is commenced, the Parties hereby agree and consent that service of process may be made, and personal jurisdiction over any Party hereto in any such action, suit or proceeding may be obtained, by service of a copy of the summons, complaint and other pleadings required to commence such action, suit or proceeding upon the Party at the address of such Party set forth in Section 10.5 of the Agreement, unless another address has been designated by such Party in a notice given to the other Party in accordance with the provisions of Section 10.5 of the Agreement. THE PARTIES HEREBY IRREVOCABLY WAIVE ALL RIGHT TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM (WHETHER BASED IN CONTRACT, TORT OR OTHERWISE) ARISING OUT OF OR RELATING TO THIS ASSIGNMENT OR THE ACTIONS OF THE ASSIGNOR, THE ASSIGNEE OR THEIR RESPECTIVE REPRESENTATIVES IN THE NEGOTIATION OR PERFORMANCE HEREOF.


