Operator Comments:

Change of process for VRU discharge. Currently the VRU discharge goes through the meter house and pushes into the Compressor suction line prior to the 2phase bottle. The proposed change is a 2" Tee fitting on the Flash Gas VRU discharge line located in the meter house. It will be placed after the meter but upstream of the current check and isolation valve. From that Tee a new check and isolation valve will be installed on a new line that will travel through a port in the siding of the meter house, so that it can connect to the existing Cureton sales header outside of the building. This change will allow VRU discharge to push into the Cureton Sales header on pad, instead of the compressor suction 2phase bottle. This will maximize VRU operations to keep pad flash gas pressures as low as possible. The valve and line inside the meter house, that we are currently using, will be locked out but not removed in case we need to use it in the future.
