Comment: Inspection of Remediation #15771 progress. The initial clean up and removal of impacted soils has occurred as part of the repair. Inspectors did not find evidence of any additional excavation or soil borings being performed at this site. Extent of impact is unknown at this time. Per Initial Form 27 (Document #402456977) Operator was scheduled to complete remedial Work 10/12/2020.

Corrective Action: In accordance with Rule 906.a Operators shall investigate, clean up, and document impacts resulting from spills/releases as soon as practicable. Supporting documentation is due within 45 days of scheduled commencement. Documentation shall include confirmation soil samples to document removal of impacts from soil in the release area and a site diagram that illustrates the release extent and location of confirmation soil samples.
