Comments:

This form was prepared to document successful completion of final reclamation efforts. The McCoy # 14-5 Well is located in the low end of an irrigated crop field. Excess irrigated water has historically ponded near the well before draining into the irrigation return pond to the west. The surface depression at this point is not associated with well abandonment/reclamation operations and proper grade of the disturbance area can be seen in the attached photos from 2019. The well was accessed via a preexisting field entrance off of Weld County Road 15. The access road from this entrance to the well has been fully reclaimed. The associated centralized battery is permitted under Location ID 311412 and remains active for producing wells. Please see the attached report for reclamation activities, details on the completed vegetation assessment, and photo documentation.
