Comments:

The tank battery is permitted with the well and is located to the south (40.389490,-104.618870). PDC's Nadine 1-24 tank battery shared a disturbance with a Noble facility (location ID 331437). PDC's portion of the disturbance has been seeded and is stabilized with perennial grasses. All remaining equipment on the disturbance, as of June 2019, resides in Noble's portion of the reclamation area and is associated with the Noble asset. The well pad access road is incorporated into the existing laydown yard, is permanently stabilized, and does not show signs of stormwater or erosion concerns. The tank battery was accessed via a preexisting canal maintenance road and remains for its historical use.
