All fluids will be removed from the partially buried produced water tank prior to excavation activities. Following the removal of the tank, soils in the direct vicinity of the tank location will be field screened for hydrocarbon impacts. Field observations and screening techniques will determine if over excavation is necessary to remove any identified impacts.

If field screening does not indicate hydrocarbon impacts to the soil around the tank, one confirmation soil sample will be collected from directly beneath the tank. If field screening indicates hydrocarbon impacts to the soil and additional excavation is needed to remove the identified impacts, 4 sidewall samples and one base sample will be collected. These samples will be collected from the final excavation area once field screening indicates the removal of identified impacts. All soil samples will be submitted for COGCC Table 910-1 analytes.
