Comment:

Location does not meet Final Reclamation requirements. Site does not appear fully, de-compacted, or properly revegetated. Location loop road & areas where equipment was located, appear compacted, gravel remains & portions are bare of vegetation. In graveled areas seeding rows are visible. Weedy species dominate in the compacted, graveled areas. Desirable vegetation is not uniform across the site.

Corrective Action:

Complete Final Reclamation of Location including removal of gravel, de-compacting road, equipment areas, and reclaiming portions disturbed by these activities. Assess vegetation & site conditions in Fall 2020. Apply remedies /conduct reclamation activities needed, as indicated by assessment, to ensure the uniform establishment across the site (& access road) of desirable vegetation. Any Reclamation Activities indicated to be complete by November 18, 2020.
