Comments:

The former Flack 7-19 well (API: 05-123-12432) was P&A'd on November 13, 2008, according to Form 6 Document Number 1666574. On September 24, 2020, OXY conducted a final reclamation inspection for the former Flack 7-19 well pad (Location ID: 323014). The former well pad has successfully been returned to agricultural use; alfalfa in 2020. The inspection determined that final reclamation has been achieved in compliance with COGCC Rule 1004, which applies to reclamation of agricultural lands. The associated tank battery is located 0.16 miles southeast of the well pad has been returned to agricultural use; alfalfa in 2020. Oxy used COGCC as drilled coordinates to locate the well. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location. The photographic log is included as Figure 1.

Based on the successful reclamation of this site, a Form 4 Sundry Notice requesting final reclamation status has been prepared for submittal to the COGCC.
