INSTRUCTIONS

Within thirty (30) days after the plugging of any well, the owner or operator thereof shall file this form in duplicate for wells on Patented or Federal lands, and in triplicate for wells on State lands, give a detailed account of the manner in which the abandonment or plugging work was carried out, including the nature and quantities of materials used in plugging and the location and extent (by depths) of the plugs of different materials; records of the amount, size and location (by depths) of casings and junk left in the well; and a detailed statement of the volume and weight of mud fluid used.

DETAILS OF WORK

Moved in and rigged up. Pulled rods. Pulled 122 joints of 2-7/8" tubing. Shot off the 6-5/8" and 8-5/8" casing at 750 ft. Pulled both 6-5/8" and 8-5/8" strings which were stuck together up to second collar and unscrewed the 8-5/8". Stripped off 40 ft. of 8-5/8" and screwed 30 ft. of 6-5/8" casing back into string and worked the 6-5/8" casing back down hole. It came free from the 8-5/8" casing. Pulled 26 joints of 6 5/8" casing. Pulled 750 ft. of 8-5/8" casing. Ran in with 25 joints of tubing to 750 ft. to run cement plug. Spotted 20 sack cement plug from 680 ft. to 750 ft. Pulled tubing out of hole. Filled hole with mud laden fluid. Gel based mud, weight 8.9. Set 10 sack cement plug at surface. The following casing was left in hole:
