INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the Reynolds Cattle 28N-19HZ location on September 11, 2020. Groundwater and impacted soil were not encountered in the PWV excavation. A liner was present beneath the PWV at this site. The PWV at this facility will be replaced. Soil samples from the excavation were submitted for laboratory analysis to determine if a release occurred. The general site layout, soil sample locations, and PWV excavation dimensions are depicted on the Excavation Site Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On September 11, 2020, following removal of the PWV, soil samples were collected from the sidewalls and base of the excavation. The soil samples were field-screened for volatile organic compounds using a photoionization detector. Soil samples B01@6', N01@5', E01@5', S01@5', and W01@5' were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. The base soil sample was also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results for all soil samples indicate that BTEX, TPH, naphthalene, EC, SAR, and pH levels were in compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

Laboratory results indicate that all soil samples were in full compliance with COGCC Table 910-1 allowable concentrations and levels; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

REMEDICATION SUMMARY

Laboratory results indicate that all soil sample concentrations were in compliance with COGCC allowable concentrations and levels at the lateral extent of the excavation. Groundwater was not encountered in the PWV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
