COMMENTS:

Per John Heil's inspection (document # 6997000205); the update is to forward analytical reports for soil following a Spill report in the vicinity of the former wellhead. Approximately 10 yards of impacted soil down to three feet (for SAR) was removed from around the wellhead on 9/3/20 and transported to Greenleaf Env. Services. Analytical data from 9/3/20 at three feet show SAR at 14.1 and 14.8; subsequent sample (sampled on 10/2/20) from the soil that was used as backfill reported SAR at 4.7. The imported soil was brought in from a nearby pipeline construction area that had excess soil. Also on 10/2/20, an additional "background" soil sample was collected targeting the "white" coloring on the soil adjacent to the pad - this SAR was reported at 48.5. The SAR impacts within the former working surface are below three feet.
