Comply with 1004 rules; Remove equipment and conduct additional reclamation/revegetation activities; Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage the reclamation until Final Reclamation has passed.

The optimum seeding window for the 2020 spring growing season has passed, therefore, a corrective action date of 11/15/2020 is being provided to allow Operator the opportunity to utilize more favorable seeding windows/conditions prior to the onset of winter.
