COMMENTS:

During a routine visit to the location it was observed that gas was escaping from the wellhead. It was determined that gas from the surface casing was leaking into the conductor casing at a fairly shallow elevation below the pad surface. As a short term corrective action, a flare was connected to the bradenhead of the wellhead until a permanent solution can be formulated. Caerus will be communicating with COGCC Engineering staff as we resolve this issue.
