#### COMMENTS:

On 10/7/2020, a Form 17 was completed with a beginning pressure of 87 psi. Gas was present at the beginning of the test. Gas was not continuous and blew down to 0 psi. There was no flow at the end of the test and a gas sample was collected. The sample will be submitted once the lab analysis has been completed. Due to the initial pressure being high, Noble will install automation, monitor and blow down as needed for a period of 6 months, ending 4/7/2021. No mitigation measures have occurred to date, the blow downs will begin after email communication with the COGCC engineer, Nick McFarland.
