Upset conditions include, but are not limited to, safety shutdowns, processing disruptions, line pressure anomalies, loss of power, emergency response, spill response, and/or operational considerations. Notwithstanding the foregoing, any such trucking shall only be conducted in accordance with the following conditions (unless needed to maintain safe operations):</p> <ul style="list-style-type: none">• Operator must utilize the Weld County approved traffic route;• trucking will be limited to the hours of 07:00 am through 08:00 pm;• trucking will not be permitted on Sundays;• the maximum number of trucks per calendar day will not exceed sixteen (16);• truck loadout air quality controls will be utilized; and• oil will be dispensed or onboarded via LACT.
