After placing the plug at 2500' yesterday, there was 1psi on the well this morning. We cut casing and circulated but are unable to pull casing. We will plan to place a suicide squeeze through the cut at 1218' up to perfs at 918'. Based on the log results I'm unsure whether we will be able to cut and pull casing above this, myself or James will contact you with the plan forward tomorrow based on pressure/flow.

Eric,

We logged this well this morning and are seeing cement above 2000' (log attached). Instead of squeezing at 2500', we would like to set a plug inside casing from 2500' to 2000' this afternoon.

-
There was 2psi of bradenhead pressure this morning so the plan right now is to cut/pull

casing at 1218' tomorrow and set a 300' open hole plug from 1218' to 918'. I'll let you know tomorrow morning if this plan changes at all.
