On Wednesday, October 21, 2020 at approximately 09:00, I, Inspector Brittani Santistevan, conducted an on-site inspection at STRONG 1-7 (KP Kauffman), at location #: 319516 in WELD COUNTY Colorado.

While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. Sign displayed at wellhead contains wrong wellhead name and API #. Replace to comply with Rule 210.b. (Corrective Action Date: October 14, 2020) See attached photo #1.
2. It appears to be stained soil under master valve. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.f.(2).d. (Corrective Action Date: September 1, 2020) See attached photo #2.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
