Operator has performed final reclamation activities, with the evidence of drill rows and straw crimped mulch. Germination of desirable species was observed but was not evident throughout the tank battery location. Operator will likely have to perform additional reclamation activities. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
