Comment:

This location does not comply with Rule 1004. Operator has closed out remediation project #15054 for a pit. Operator has backfilled and contoured the pit and a portion of the access road but has not seeded- see Photos 2-3.

Just south of the pit is a disturbance area associated with the tank battery that is mostly bare soil or only growing annual vegetation- see Photo 4.

The well location is not reflective of reference areas and has the establishment of a List C noxious weed, cheatgrass- see Photos 5-7.

Corrective Action:

Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Operator may have to perform both fall and spring weed management to properly control cheatgrass.
