Basis for Review: CA dates are not per the guidelines

Since the COGCC does not provide an applicable basis for review option to the Operator, the selected option may not be applicable, but this response is needed to create full transparency for the record. The alleged vehicle

Operator Comment: tracking CA noted in the inspection photo with the comment "Vehicle tracking on to county road from lease road" is not valid. The section of road noted in the inspection photo is a County Road (Chipperfield Lane/County Road 326) and not the responsibility of the operator or within the jurisdiction of the COGCC. The lease/access road for this location begins at the locked gate located approximately 0.3 miles to the east of where the inspector's photo was taken. A review of Garfield County records will confirm.

The alleged "sediment migration" near the combustor is also being disputed, as there is no evidence of "sediment migration" which the Operator is assuming is referring to erosion. The noted area around the combustor is void of vegetation as this area is intentionally treated with herbicide as part of our bare ground treatments and fire safety program. The area around the combustor is within the working surface of the production facility and is a graveled surface which is considered final stabilization.
