Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Revegetation activities shall be complete no later than 11/16/20 or as soon as environmental conditions will permit.
