Comment: Canada thistle at site has been controlled; however Absinth wormwood (State B list Noxious weed) is still evident, with new growth emerging at base of senesced plants. Operator is advised that effective weed control usually requires several control applications, dictated by monitoring. Location still does not appear fully re-contoured/graded. Access road runs through Location to surface owner facilities. Refer to Photo Log attached.
