Request an Exception to Ground Water Sampling Requirements in Greater Wattenberg Area Rule 318A.e(4) or in Statewide Rule 609.c. Request a Previously Sampled Water Source in the COGIS database be used to meet sampling requirements as described in Rule 609.d.(3).

COMMENTS

After conducting good faith efforts regarding groundwater sources within the 1/2-mile buffer of the BJU G35 496 well pad, it has been determined that thirty-nine (39) groundwater wells are within the buffer zone. All thirty-nine groundwater wells are associated with two different COGCC Remediation Projects:

COGCC REM # 10527 K35 CDP – thirty-six groundwater wells located south of the G35 well pad are associated with this project.
COGCC REM # 10691 Divide Road – three groundwater wells located north of the G35 well pad are associated with this project.

Based on the unsuitable conditions of the thirty-nine groundwater wells under COGCC REM #10527 and COGCC REM #10691, Caerus requests an exception to COGCC Rule 609 sampling for the NPM G35 496 well pad. This determination applies to the following wells listed below:
