Comment:

Previous inspections observed noxious weeds establishing on the access road and Location, and required Operator to comply with Rule 1004.e. Operator submitted Resolution doc. #402513735 stating weeds were sprayed.

Due to the onset of winter conditions and plant dormancy, it is unclear if sufficient weed management activities have been conducted per the corrective actions. A followup inspection will need to be conducted during the 2021 growing season to determine compliance with Rule 1004.e and corrective actions; Ongoing weed monitoring/management is required until Location passes final reclamation.
