A comparison of aerial imagery is provided (Attachment A and B) demonstrating that surface disturbance occurred prior to 1999, before the well and location 2/2A applications were submitted. Current photos of the location are provided in Attachment C. No plans exist for future development. SandRidge is requesting abandonment and closure of the COGCC permitted well (Facility ID 441212) and location (Location ID 441213).
