## Comment

Operator previously received an approved 502.b delayed operations interim reclamation waiver (Doc. #401721595). Sundry expired 2/5/2020 and reclamation was required. FIR #696201334 observed that interim reclamation appeared to have been conducted; after additional review of aerial imagery and observations of the Location it has been determined that this was incorrect.

Though work had been conducted on the western areas of the Location, reclamation of areas not needed for production on the Location has NOT been conducted pursuant to 1003 requirements, and per Form 4 #401721595 COAs.

## Corrective Action

Comply with COGCC 1003 rules and conduct interim reclamation. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. A CA date of 2/5/2020 is being applied since this is the expiration of the interim reclamation delayed variance doc. #401721595.

Comment: Inspection #696201334 and #696201673 observed insufficient or missing stormwater and erosion control BMPs on the Location in accordance with Rule 1002.f.

It was observed in this inspection that a sediment trap and perimeter ditch has not been constructed in accordance with good engineering practices for the sites conditions; slopes on location exposed soils- erosion/stabilization BMPs not installed on slopes.

Corrective Action: Install or repair required BMPs in accordance with Rule 1002.f and good engineering practices; Maintain BMPs in proper functioning condition; Continue stormwater management until Location receives a passing final reclamation inspection, pursuant to Rule 1002.f.

Interim reclamation due on the Location. Temporary stabilization controls will be required on areas to be interim reclaimed; Long term stabilization BMPs will be required on all areas not interim reclaimed.
