Comment Weeds are only partially controlled, as approximately 150 treated musk thistles observed. Many individuals have flowered and dispersed seed and rosettes remain. This will likely result in continued infestation during 2021 growing season.

Corrective Action Control weeds. Weed control strategy including multiple treatments and control methods is needed to control infestation, as annual treatment does not appear sufficient.
