On 11/6/2020 Reclamation Specialist Trujillo conducted an interim reclamation and stormwater inspection at TEP's Federal GM 32-4 location in Garfield County, Colorado.

This inspection is a followup to #696201578 to document compliance with the following corrective actions:

603.f- Statewide equipment, weeds, waste, and trash requirements

1002.f.(2)C- Stormwater

It was observed in this inspection that the Location remains out of compliance with COGCC Rules and corrective actions:

-603.f: Equipment observed stored on Location in FIR #696201578 has been removed. Additional equipment not needed for production, or trash debris observed on Location.

-1002.f.(2)C- Erosion observed in FIR #696201578 appears to have been repaired, however no BMPs to stabilize/protect the slopes have been installed per the corrective actions.

Comment: [FIR #696201578](#) observed that were BMPs missing, or insufficient, to stabilize slopes on the southwestern interim areas and erosion degradation was evident. Inspection required Operator to comply with Rule 1002.f.(2)C.

It was observed in this inspection that work appears to have been conducted to repair the erosion degradation, however, BMPs do not appear to have been installed; BMPs remain missing, or insufficient to stabilize and protect slopes. This corrective action has not been addressed and remains applicable.
