Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Operator has failed to perform final reclamation as gravel remains throughout the location and the access road, which have not been re-contoured or re-graded. Operator has failed to manage and control weedy vegetation, which includes but not limited to puncture vine (List C CO noxious weed) and Musk and Scotch thistle (List B CO Noxious weeds). Fencing material and Operator signs remain as well.</p> <p style="color: red;">Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p style="color: red;">Corrective action date is being back dated to when all final reclamation activities should have been completed.</p> <p style="color: red;">Operator shall perform final reclamation activities as soon as possible.</p>	Date <b>10/31/2020</b>
