Comment: -Stormwater controls on the access road are not adequate and already failed. Bare soils on shoulders and drainage pathways are rilling and channeling.
 -Vehicle tracking along flowline reclamation.
 -Stormwater BMP in the northwestern project area is failed.

Corrective Action: -Stabilize erosion within the project area. Stormwater BMPs need to be selected, sized, installed, and maintained according to good engineering practices.
 -Access to flowline ROW should be closed to avoid further reclamation requirements.
