The Columbine Springs wells have utility as producers at a sustained \$3.25/mcf. The CBM field's water production at lower gas prices make the wells uneconomic. The wells are unable to produce without moving water. Future plans to reactivate the well are pending. The wells have a cast iron bridge plug above the perms, and a wellhead master valve at the surface. Form 5A is in process.
