Noble Energy respectfully requests TA status. The well is closed to the atmosphere via a Quartzpack set at 6336'-6747' on 10/15/2020. The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TA'd for the MIT. Noble will plug and abandon within the next 5 years. Noble is currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 402527431. Successful MIT was performed on 10/20/2020 and was submitted on doc # 402536422. This well is tagged with a blue tag.
