The associated centralized tank battery is located at 40.41333, -104.5811, permitted separately, and is associated with the PJ 1, 3, 5, 8I wells. The access road pre-dates the well and remains in place for its historic purpose of agricultural access. All portions of the access road specific to the P J 2 well have been fully reclaimed.
