#### COMMENTS:

Mustang respectfully requests COGCC approval to conduct an alternate MIT on the Clough 27-11-6S-94W with lower pressure. Mustang will monitor braidenhead pressure for 24 hours while the well is shut in. This will test the braidenhead for pressure using the wells own energy in the production casing. Strip charts will be provided on both the production casing and braidenhead.

The well was shut in for surface facility work, and Mustang has no reason to believe that the wellbore integrity is compromised. Unfortunately, due to extenuating circumstances with COVID and work force availability, the well remained shut- in past the 24 month mark in April 2020. COGCC issued a warning letter on September 16, 2020 (Doc #402491048) notifying Mustang that an MIT is due. The timeline given by COGCC to complete an MIT is December 31, 2020. Mustang does not foresee rig availability prior to that date.
