The facility is scheduled for closure activities late 2020. This Form 27 is being submitted provide notification of backfilling and reclamation of the pit. To satisfy COA #1 on eForm 27 #402437864, Grizzly will conduct routine monitoring of the reclaimed area for subsidence. To satisfy COA #2 on eForm 27 #402437864, documentation of final disposition of pit fluids, pit bottoms, and pit liner is included as an attachment to this form. Following the approval of Supplemental eForm 27 #402483851, Grizzly backfilled the pit with the native spoils that were generated during pit construction to match existing grades. The area was seeded and crimped straw mulch was applied as protective cover. The reclaimed area has been fenced to protect the seeded area and promote successful germination and revegetation. The fencing will be removed after successful revegetation of the reclaimed area. A copy of the surface owner approved seed mix tag is attached.
