There was a Nio re-frac in 2008 and unfortunately there were MANY errors on the 5A submitted at this time. The biggest error is the date of first production for both Nio and the Nio/Codell, because it claimed it was in 2008 when the re-frac happened, ignoring the original Nio completion date in 2004. Documentation and details of the work performed is included in these attachments.
