COMMENTS:

The 2019 annual bradenhead test (Form 17 conducted 9/19/2019, doc# 402190786) reported surface casing pressure of 382 psi. A liquid sample was taken on 9/19/2019 (Form doc# 402333879). Bonanza Creek submitted a sundry that was approved, requesting to commence a mitigation plan prior to work (Form 4 submitted 11/18/2019, 402241922). Bradenhead abatement notice for 7/10/2020 submitted (Form 42 7/31/2020, doc# 402457402).

To mitigate pressure, a 14-day blowdown/14-day build-up procedure was conducted with the bradenhead connected through a tank and combustor during the blowdown. A liquid sample was taken on 6/23/2020 (Form 43 submitted 7/9/2020, doc# 402440423). During the 2020 annual bradenhead test, there was 59 psi on the bradenhead (Form 17 conducted 8/7/2020, doc# 402468627). No sample was taken. Attached is a SCADA pressure chart from 11/10/2020-12/10/20 reflecting pressures above 50 psi.

Bonanza Creek requests to conduct a 30-day blowdown followed by a 7-day build up as a mitigation plan. Work will be scheduled for January 2021. Bonanza requests a minimum of 90 days from the date work begins to submit a Form 4 subsequent report with mitigation results. A gas/fluid sample is planned to be collected prior to mitigation (if present) with analysis submitted via Form 43. Pressure during mitigation will be recorded and a chart will be provided in the post-mitigation subsequent report sundry notice. A bradenhead abatement test will be conducted and submitted via Form 17.
