#### COMMENTS:

During a field inspection with the COGCC, found P&A marker broke off unable to confirm the well had been plugged correctly. Action taken : put in 811 call on well location, waited till 811 had cleared; notified Rick Moran with COGCC; pot holed well, found well had been plugged correctly. Well did not have surface casing, just cement in open wellbore. Craig Burger COGCC, confirmed we were good with installing a 3' piece of surface casing over old cement (3-4' below surface), topped off with cement, welded on Beaded information plate as per COGCC. Back filled hole, location will be reclaimed next spring.
