COMMENTS:

The Bradenhead test dated 9/9/2020 had an initial pressure of over 50psi. Extraction was unable to successfully mitigate the bradenhead pressure through a blowdown strategy. Per Operator Guidance Order NO. 1-232 Extraction submits the following as an alternate Bradenhead mitigation strategy:

To comply with the operator guidance Extraction requests to route the bradenhead gas to a catadyne heater within 20' of the wellhead to maintain bradenhead pressure below the 50psi threshold. Extraction has left the bradenhead shut-in after completing the bradenhead blowdown mitigation strategy.

Operator shall implement measures to get an estimate of the gas flow rate and/or volume from the bradenhead.</p> <p>3. Within thirty days of 09/28/2021 , submit a Form 4 Sundry that summarizes current well condition. The sundry should include details of the future plans, sample analysis interpretation, bradenhead test description, and the flow rate information and pressure data.</p> <p>4. If a sample has not been collected from surface casing within the last twelve months collect bradenhead gas samples for laboratory analysis. Sampling shall comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results shall be provided to the COGCC within three months of collecting the samples.</p>
