There was sparse desirable vegetation observed throughout the location, which is not reflective of reference area vegetation. This location was seeded summer of 2020 so this location did not even have a full growing season. It is highly unlikely, especially with the lack of precipitation for 2020, that this location would already meet Rule 1004 vegetative standards. Refer to the attached inspection photos.
