Proposed Procedure:

1. MIRU. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 7289'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Codell perms @ 7339')
4. TIH with CIBP. Set BP at 6976'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Niobrara @ 7026')
5. TIH with casing cutter. Cut 4.5" casing at 2500'. Pull cut casing.
6. TIH with tubing to 2550'. Mix and pump 100 sxs 15.8#/gal CI G cement down tubing. (Courtesy plug from 2550'-2300')
7. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations
8. Pick up tubing to 1430'. Mix and pump 100 sxs 15.8#/gal CI G cement down tubing. (Pierre coverage from 1430'-1230').
9. Pick up tubing to 600'. Mix and pump 219 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
10. Cut surface casing 6' below ground level and weld on cap.

### Description

	<p>For Wells with known Bradenhead pressures:</p> <ol style="list-style-type: none"> <li>1) Provide 48-hour notice of plugging MIRU via electronic Form 42.</li> <li>2) The plug at 1430' needs to be placed and have an 8-hour WOC to assure that all fluid migration has been stopped. If that doesn't isolate the flow, additional attempts in front of the surface shoe plug will need to be attempted. Other downhole potential squeeze opportunities may need to be looked at before the 600' plug.</li> <li>3) Prior to placing the 600' plug: verify that all fluid migration (liquid or gas) has been eliminated. If evidence of fluid migration or pressure remains, contact COGCC Engineer for an update to plugging orders.</li> <li>4) After isolation has been verified, pump plug and displace. If cement is not circulated to surface, shut-in, WOC 4 hours then tag plug – must be at 350' or shallower and provide 10 sx plug at the surface. Leave at least 100' of cement in the casing for each plug.</li> <li>5) Properly abandon flowlines as per Rule 1105. File electronic Form 42 once abandonment is complete. Within 90 days of an operator completing abandonment requirements for an off-location flowline or crude oil transfer line, the operator must submit a Flowline Report, Form 44.</li> <li>6) With the Form 6 SRA operator must provide written documentation which positively affirms each COA has been addressed.</li> <li>7) After placing the shallowest hydrocarbon isolating plug (1430'), operator must wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact COGCC engineering before continuing operations.</li> </ol>
	<p>Operator shall implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well plugging operations do not constitute a nuisance or hazard to public welfare.</p>
	<p>Prior to starting plugging operations a Bradenhead test shall be performed if there has not been a reported Bradenhead test within the 60 days immediately preceding the start of plugging operations.</p> <ol style="list-style-type: none"> <li>1) If, before opening the Bradenhead valve, the beginning pressure is greater than 25 psi, sampling is required.</li> <li>2) If pressure remains at the conclusion of the test, or if any liquids were present during the test, sampling is required.</li> </ol> <p>The Form 17 shall be submitted within 10 days of the test. Sampling shall comply with Operator Guidance - Bradenhead Testing and Reporting Instructions. If samples are collected, copies of all final laboratory analytical results shall be provided to the COGCC within three (3) months of collecting the samples.</p>
