On 12/20/2020, Reclamation Specialist Trujillo conducted a final reclamation and stormwater inspection at Northstar Resources Inc's Federal 32-3 location in Mesa County, Colorado.

It was observed that separator equipment remains on the Location. Inspection is being submitted to BLM as notification.

Location/Well is considered "orphan well"; Per Order #1V-646 on 11/1/2017, the Director terminated Northstar Resources operator number (#64310), rescinded the Form 1 #709166 and revoked Northstar's right to conduct oil and gas operations in Colorado.
