COMMENTS:

The 2019 annual bradenhead test (Form 17 conducted 9/12/2019 doc# 402183880) reported surface casing pressure of 101 psi. A gas sample was taken on 9/12/2020 (Form 43 submitted 7/6/20, doc# 402438209). Bonanza Creek submitted a sundry that was approved, requesting to commence a mitigation plan prior to work (Form 4 submitted 11/11/2019, doc# 402235790).

Pressure data indicated that the initial blowdown conducted with the 9/12/2019 bradenhead test resulted in pressures stabilized below 50 psi without having to conduct mitigation work. During the 2020 annual bradenhead test, there was 48 psi on the bradenhead (Form 17 conducted 8/26/20, doc# 402544366). No sample was taken. Pressure was monitored manually until 10/13/2020 when SCADA was installed. This well is now on a pressure management plan, which includes connecting it to SCADA and continuously monitoring pressures on the bradenhead.

This well is consistently maintaining pressure less than 50 psi on the bradenhead. The mitigation abatement bradenhead test conducted 12/4/2020 doc# 402547810 reported surface casing pressure of 47 psi. A gas sample was taken and will be submitted via Form 43. Attached is a SCADA pressure chart from 10/29/2020 – 11/25/2020 reflecting the low pressure, stabilized below 50 psi. Bonanza Creek requests to close the mitigation plan and continue to assess the well monthly and during future annual bradenhead tests.
