1. MIRU. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6373'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nio/Codell perms @ 6423')
4. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement. (Courtesy Plug)
5. TIH with tubing to 1420'. Mix and pump 108 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
6. Cut surface casing 6' below ground level and weld on cap.
