It was observed in this inspection that approximately 0.5 acres of the Location has been left graveled as indicated within the SOVR. Minimal contouring performed. With exception to an area on the northwest end of the Location, remaining areas of the Location appear to be progressing towards COGCC 1004 requirements; Additional reclamation appears to have been conducted along northwestern areas of the Location, reclamation is in process.

Continue to monitor and manage and conduct additional reclamation activities as needed until Location receives a passing final reclamation inspection.
