General Comment:**COGCC Inspection Report Summary**

On 12/23/20, I, Inspector Scott Ramsey, conducted a Safety and compliance inspection at 31 Operating 22-44, at Location # 316209 in Rio Blanco county Colorado.

This is a limited inspection for Safety and Compliance.

While there, I observed that location has not been visited in quite some time, nor had the access roads been plowed.

During this inspection the following possible compliance issues were observed:

- Debris throughout location (dead weeds)

Refer to photograph of observed compliance issue.

I spoke with Leven who has worked for 31 operations at the lay down yard. He stated that the compressors were pulled out of his field back in October and that he and other pumpers on his side of the field went through and shut all of the wells in November. He had also given me a map of the field and pointed out that he was not sure of some locations that had supply gas running to the burners had been shut off. He also stated that they did NOT evacuate any of the flow lines of fluid. He did not go out to the field with me, he suggested that I could shut the supply gas off if I came across any that needed it. He also stated that all of their phone numbers had been disconnected. A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
